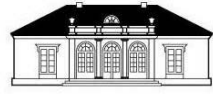

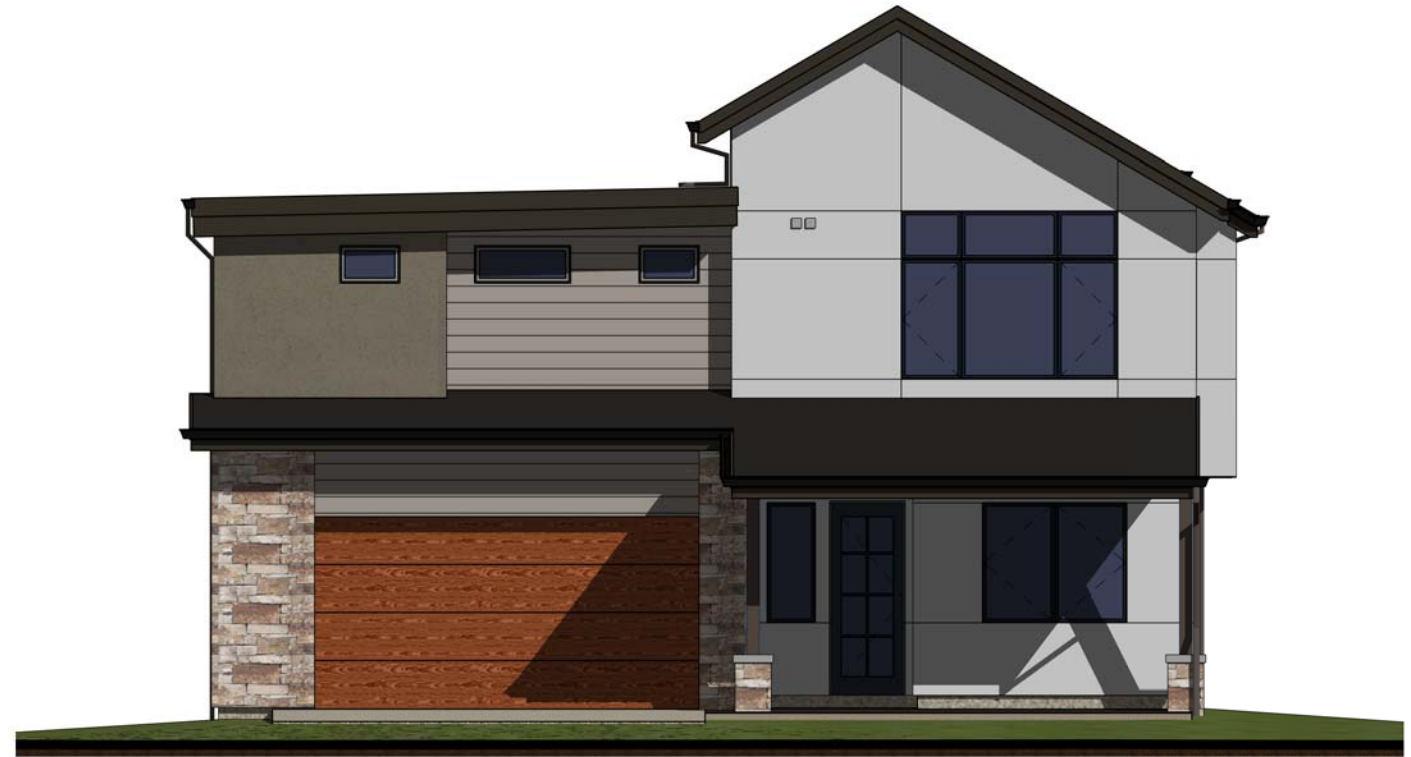

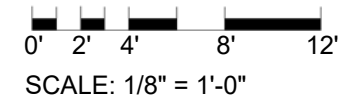
SIDE ELEVATION 2

FRONT ELEVATION-

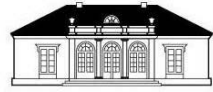

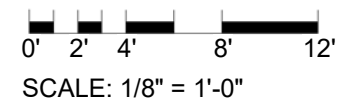

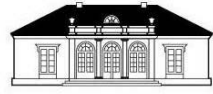

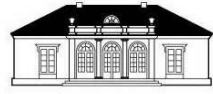


SIDE ELEVATION 1 OPTION 1

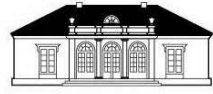
3D view 1 OPTION 2

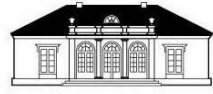


3D view 2 OPTION 1

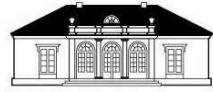

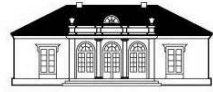


3D view 4 OPTION 1
